- keep files of primary records and current operating records.


## 4. RANGE OF OCCUPATIONS ACCESSIBLE TO THE HOLDER OF THE CERTIFICATE

The graduate is employed in the field of gardening within its sector (florist, orcharding, fruit growing, vegetable growing or viticulture), primarily in reproduction of fruit and ornamental material, floriculture, fruits and vegetables, in the establishment and maintenance of orchards and landscape, when arranging flowers, making bouquets and storage and processing of horticultural products. After gaining the necessary experience in the field is ready for private enterprise in the area.  
Examples of possible jobs: fruit and vegetable grower, florist, forest-tree nurserymen, binder-arranger, a worker in the plant protection (conservationists), or wine/vineyard-grower.
